Dear partners and colleagues! 2023 was an important year for "NMSC "Kazmortransflot" LLP. In the reporting year, "NMSC "Kazmortransflot" LLP celebrated its 25th anniversary, on which I would like to congratulate the employees and partners of the Company on such a significant event on behalf of the Sole Participant.

Despite the unprecedented difficult working conditions of the shipping industry in the reporting period caused by geopolitical tensions and sanctions, the management and employees of "NMSC "Kazmortransflot" LLP, as well as the captains and crews of ships, successfully fulfilled all the Company's obligations to partners and customers.

The Supervisory Board of "NMSC "Kazmortransflot" LLP notes with satisfaction that despite the serious trials that the global economy has undergone, the Company has not deviated from its strategic course, continues to keep a high bar and achieve its goals. Moreover, the Company has achieved record results in a number of key production and financial indicators.

In January 2023, as part of the visit of the Head of State Tokayev K.K. to the UAE, in Abu Dhabi, an Agreement on strategic partnership was signed between JSC "NC "KazMunayGas" and AD Ports Group. In order to implement the Agreement between "NMSC "Kazmortransflot" LLP and International Maritime Investments Ltd. (a subsidiary of AD Ports Group), a joint venture Caspian Integrated Maritime Solutions Ltd was established in February 2023 on the basis of the Astana International Financial Center.

In accordance with the instructions of the Government on the development of alternative oil export routes, as well as within the framework of the signed General Agreement on Oil Transit between JSC "NC "KazMunayGas" and SOCAR, shipments of Tengiz oil along the Aktau-Baku-Ceyhan route began in March 2023, where "NMSC "Kazmortransflot" LLP was identified as the Kazakh side's sea carrier.

In November 2023, the ceremonial acceptance of the tankers "Taraz" and "Liwa", which were acquired by a joint venture from the Dutch shipbuilding company Damen Shipyard, took place in the port of Aktau.

According to the results of the work of "NMSC "Kazmortransflot" LLP in 2023, the Company's final profit amounted to 9 051 million KZT, against a planned profit of 2 950 million KZT.

Summing up the results of 2023, despite the geopolitical situation prevailing in the reporting year, on behalf of the Supervisory Board of "NMSC "Kazmortransflot" LLP, I would like to express my gratitude to the Management and the entire staff of "NMSC "Kazmortransflot" LLP and the Company's partners for fruitful cooperation and strengthening business relations.

Dear readers! I present to your attention the integrated annual report of "NMSC "Kazmortransflot" LLP, in which we reflect the results of financial and production activities for 2023, and also share the prospects for further development of the Company.

The reporting year was an anniversary year for "NMSC "Kazmortransflot" LLP and we can sum up the results of the Company's 25-year work.

Despite the difficulties taking place in the world, 2023 was a successful year for "NMSC "Kazmortransflot" LLP. The company provided uninterrupted and reliable transportation of oil, container and general cargo.

In accordance with the production program for the transportation of containerized cargo along the Trans-Caspian International Transport route in the Aktau-Baku direction transported 19 868 containers to the TEU, similar compared to last year.

The Company's consolidated revenue for 2023 increased by 13% compared to 2022 and amounted to 142 975 million KZT, consolidated profit amounted to 9 051 million KZT, against a planned profit of 2 950 million KZT.

In 2023, the Company fully repaid loans on the Altai and Alatau tankers to the Sole Participant, paying 26 120 million USA dollars. This made it possible, by the decision of the Sole Participant, to pay dividends and by the end of 2023 in the amount of 7 360 billion KZT.

In the reporting year, "NMSC "Kazmortransflot" LLP continued to work on the implementation of strategically important investment projects, including the expansion of the marine fleet. Much attention was paid to one of the main priorities of our work and the task of the Head of State – to participate in the search for alternative oil transportation routes and the expansion of the marine fleet in the Caspian Sea and in the Open Seas.

Along with achievements in the production sector, ensuring safe working conditions for employees of "NMSC "Kazmortransflot" LLP remains an important priority. We pay special attention to compliance with occupational safety standards. Measures aimed at reducing the level of injuries and the number of emergencies are regularly carried out at the company's production facilities.

The achievement of high results in 2023 is the common merit of all employees of "NMSC "Kazmortransflot" LLP, captains and crew members of ships, and other coastal units.

In conclusion, I would like to thank JSC "NC "KazMunayGas" and partners for constructive cooperation and trust, and the entire staff of "NMSC "Kazmortransflot" LLP for the work done and professionalism. We appreciate the contribution of each of you.

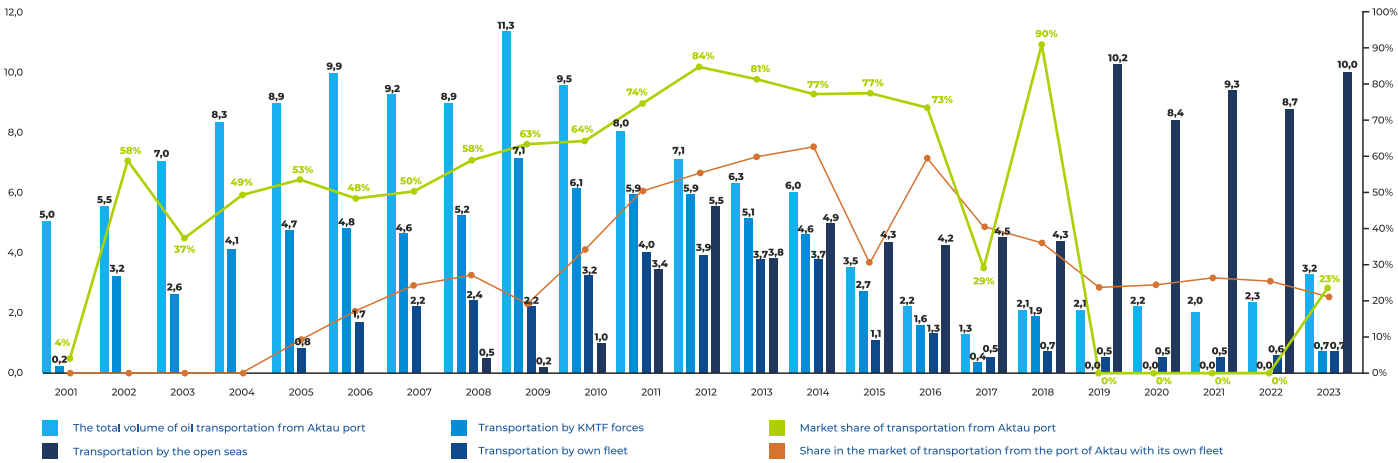

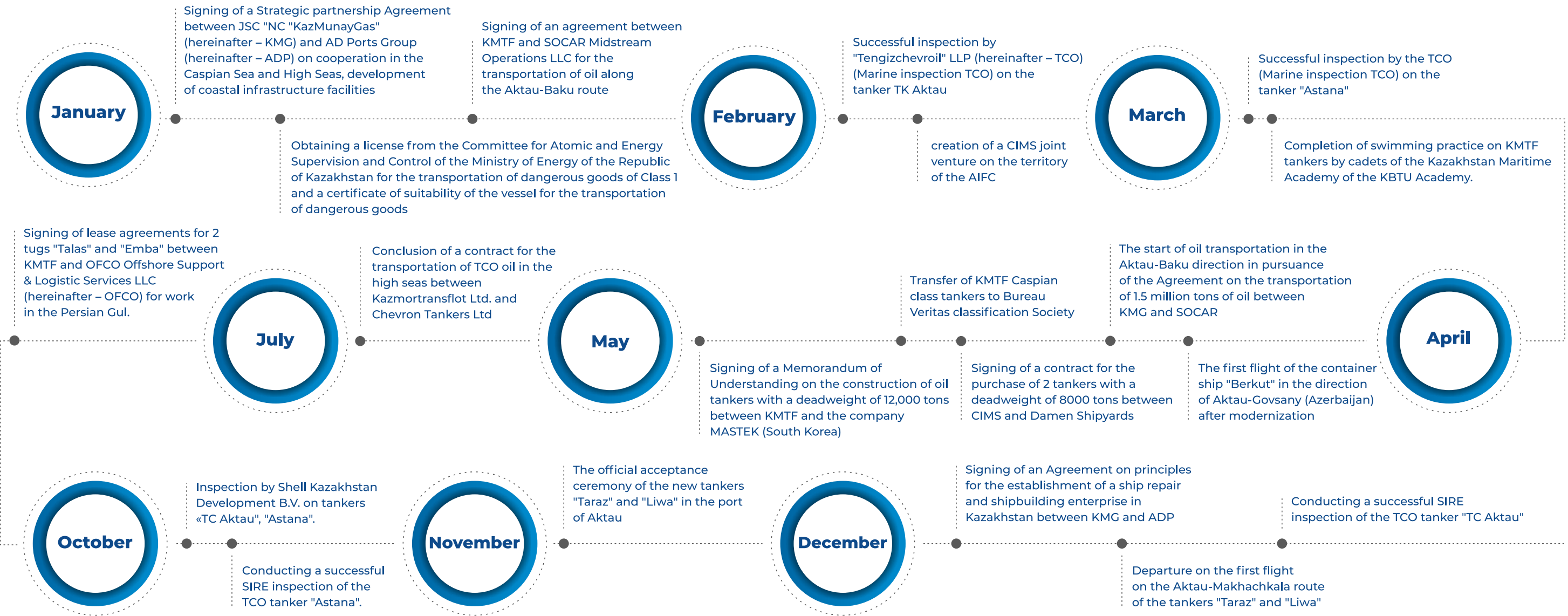
The history of oil transportation growth

The officers of the Partnership are members of the Supervisory Board and the Management Board.

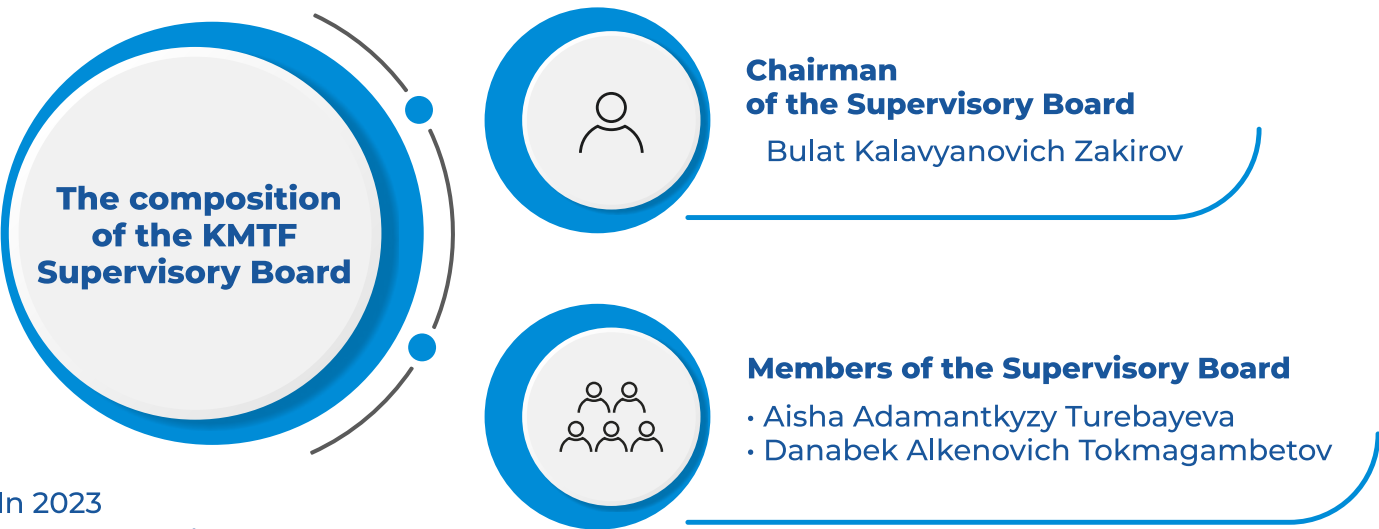
The KMTF Supervisory Board

The Supervisory Board is headed by a Chairman who is appointed by the Sole Participant from among the members of the Supervisory Board.

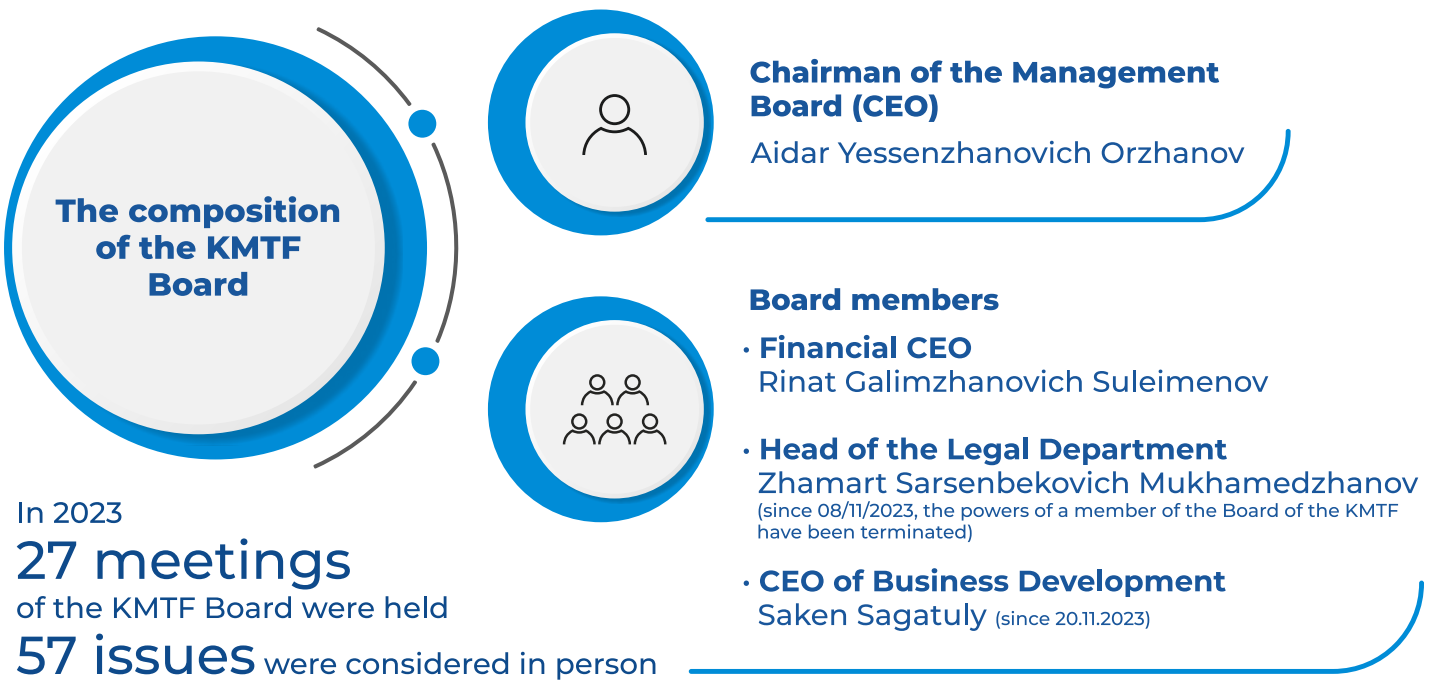

The Audit Commission

The Audit Commission (auditor) (created by the decision of the Sole Participant, if necessary) is a supervisory body that monitors the financial and economic activities of the KMTF, as well as the current state of its affairs.

The Audit Commission (Auditor) necessarily conducts an audit of the KMTF financial statements before its approval by the Sole Participant.

As of December 31, 2023, according to the KMTF Charter, the decision of the Sole KMTF Participant on the establishment of an audit commission (auditor) has not been taken.

STRATEGIC INITIATIVES AND PRIORITY AREAS OF ACTIVITY

KMTF's strategic initiatives and priority areas of activity are defined within the framework of the "Development Strategy of JSC NC KazMunaiGas for 2022-2031" approved by the Board of CEO's of KMG in 2021 (hereinafter referred to as the Strategy). This Strategy is a single goal-setting document for KMG subsidiaries and affiliates. **2 main strategic directions of activity and 4 strategic goals** have been identified.

The achievement of KMG's four strategic goals is ensured through the implementation of 25 strategic initiatives. Strategic initiatives are defined for subsidiaries and affiliates depending on existing activities and development prospects.

In order to increase the efficiency of the value chain of the KMG Group of companies, the strategic initiative "Synergy for Sea Transportation" is being implemented.

The Maritime Transportation Initiative is aimed at maintaining positions in terms of quality and efficiency of transport services among shipping companies, both in the Caspian region and outside the Caspian Sea, by achieving high technical standards of their own fleet, safety of navigation, management and production processes and a high professional level of employees.

The implementation of this initiative is ensured by the presence of KMTF in the maritime transportation market. Three promising business areas have been identified to ensure the implementation of this initiative:

1) Oil transportation in the open seas, aimed at strengthening the position of the National Maritime Carrier in the Black Sea-Mediterranean region and the consistent growth of the participation of KMTF's own company in the total volume of transportation of Kazakhstani oil cargoes in the open seas with the potential build-up of its own large-tonnage Aframax and/or Suezmax type fleet.

2) Transportation of oil through the Caspian Sea by KMTF's own tankers, as well as through the leasing of KMTF tankers for the transportation of oil along routes between other ports of the Caspian Sea.

3) Servicing of oil and gas fields on the Caspian shelf through expanding the share of KMTF's presence in the fleet services market and strengthening its role in offshore project maintenance projects. For the development of the direction, it is necessary to build/purchase specialized vessels of the service fleet.

According to the results of activities for 2023, the following results were achieved in the main areas of activity:

- Open seas – oil transportation is carried out by its own large-tonnage fleet, Aframax Altai and Alatau tankers, from the ports of Novorossiysk and Ceyhan. In order to fulfill oil transportation obligations under the Framework Agreement signed in 2018 between KMG, KMTF and KMG International, a third-party fleet and tanker pool created in 2022 between KMTF and ADP are involved. In 2023, the 2nd tanker was transferred to KMTF management, and currently the tanker pool consists of 4 tankers, 2 KMTF tankers and 2 ADP tankers. In the future, the KMTF is considering increasing the tanker pool.
- Caspian Sea – oil and cargo transportation is carried out by oil tankers "Astana", "Almaty" and "TK Aktau" with a deadweight of 12,000 tons, bulk carriers "Beket-Ata" and "Turkestan", container ships "Barys", "Sunkar", "Berkut". The main destinations are the ports of Azerbaijan, Russia, Turkmenistan and Iran.
- In January 2023, in order to strengthen investment cooperation between the Republic of Kazakhstan and the United Arab Emirates, KMG and ADP signed a Strategic partnership Agreement. The purpose of the Agreement is to implement projects in the field of development of maritime transportation and logistics services in the Caspian Sea through a joint venture. Within the framework of cooperation with ADP in 2023, KMTF implemented investment projects "Creation of a joint venture in the territory of the AIFC", "Purchase of 2 oil tankers with a deadweight of 8000 tons".
- In April 2023, CIMS signed a contract with the Dutch company Damen Shipyards for the purchase of tankers. In October, the solemn acceptance of tankers took place, the vessels were named "Taraz" and "Liwa".
- One of the important events of this year is the resumption of oil transportation along the Aktau-Baku route. According to the five-year Agreement signed in 2022 for the transportation of up to 1.5 million tons of Kazakh oil through the Baku-Tbilisi-Ceyhan oil pipeline, KMTF was appointed a marine operator, on a parity basis with the Azerbaijani side, the tanker fleet began transporting oil from March 2023.
- Container and dry cargo transportation is carried out from the port of Aktau to the ports of Azerbaijan, Iran, Turkmenistan, and Russia.
- The service fleet is represented by tugs "Irgiz", "Emba", "Talas". In 2023, the vessels were involved in the provision of marine supply vessel services as part of the exploration project at the "Zhenis" site under an agreement with "Zhenis Operating" LLP. At the end of the contract in May 2023, an agreement was reached with OFCO on the long-term lease of tugboats. In the second quarter of 2023, the tugs "Emba" and "Talas" were mobilized to the Persian Gulf, and the tugboat Irgiz was sent in December. Due to the lack of proposals for the operation of barges and plans to improve the efficiency of fleet operation, in 2023 the barge platforms "KMG-105", "KMG-106", "KMG-107", "KMG-108" were implemented.

INVESTMENT PROJECTS

Conversion of the MCV Berkut vessel into a container ship

As part of the modernization of the MCV series of vessels, in March 2023, the conversion of the third MCV "Berkut" vessel to a container ship between was completed

On April 07, 2023

the ship was sent on its first voyage in the direction of Aktau-Govsany (Azerbaijan)



Purchases of 2 oil tankers with a deadweight of 8000 tons

In order to develop alternative export routes for KMTF oil, the investment project "Purchase of 2 oil tankers with a deadweight of 8,000 tons" was implemented.

In April 2023, the CIMS joint venture signed a contract for the purchase of tankers with the Damen Shipyards shipbuilding company.

In November 2023

the solemn acceptance of 2 new tankers "Taraz" and "Liwa" took place

In December 2023

, the tankers launched their first flight on the Aktau-Makhachkala route



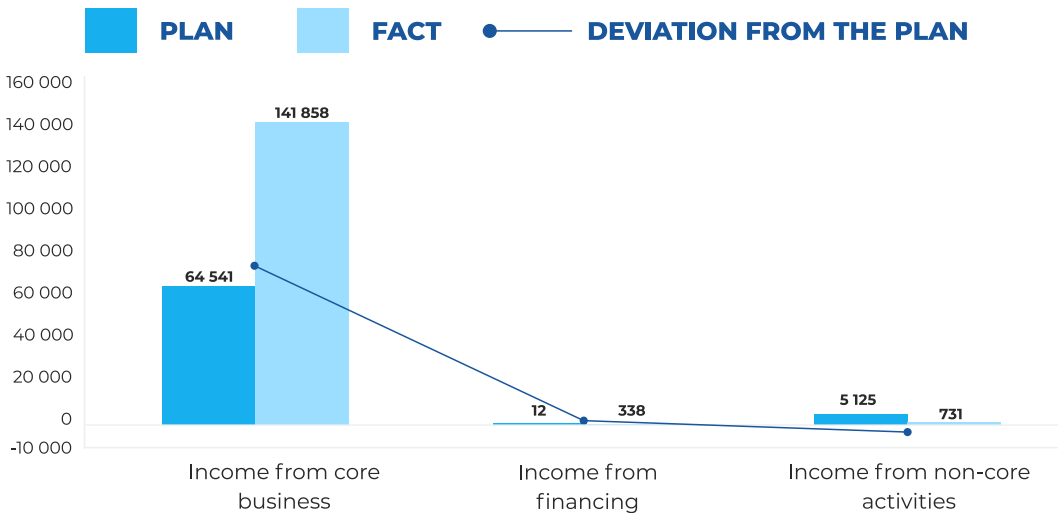

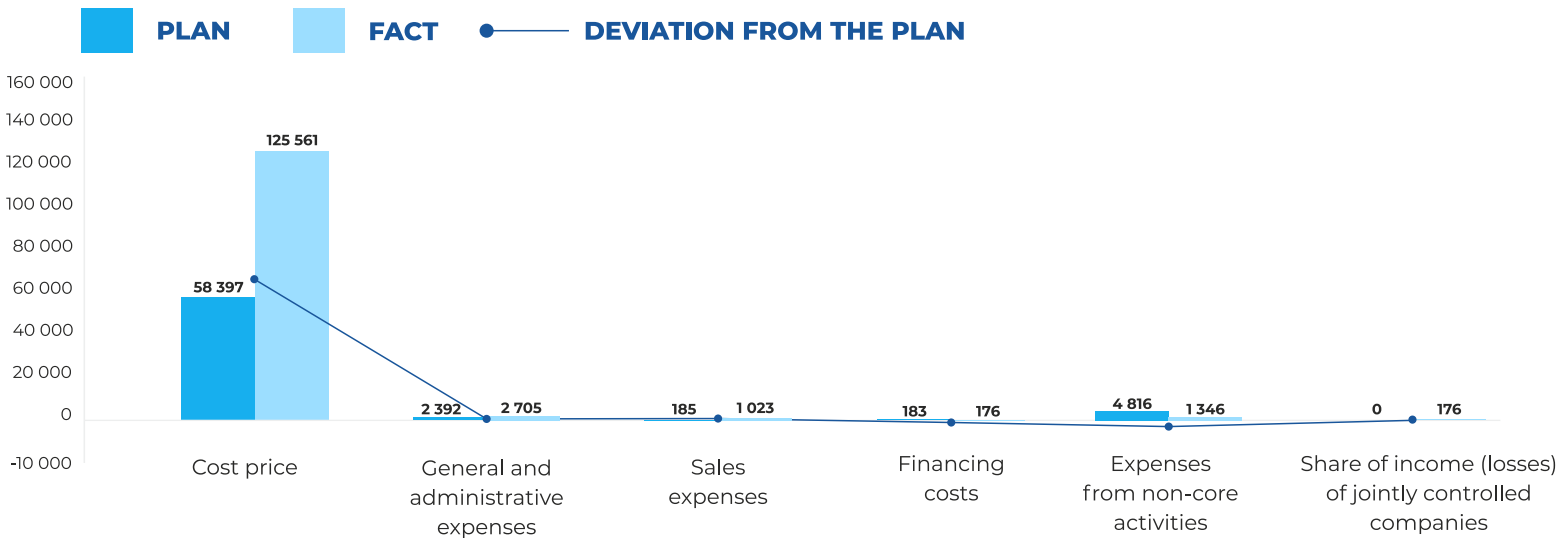

As a result of financial and economic activities in 2023, the total profit of the ITF amounted to 9 051 million KZT, against the planned profit of 2 950 million KZT.

The main reasons are: an increase in the actual tariff on the high seas by 50% (fact – US\$ 20.33/plan – US\$ 13.52) due to an increase in the level of the World Scale tariff scale.

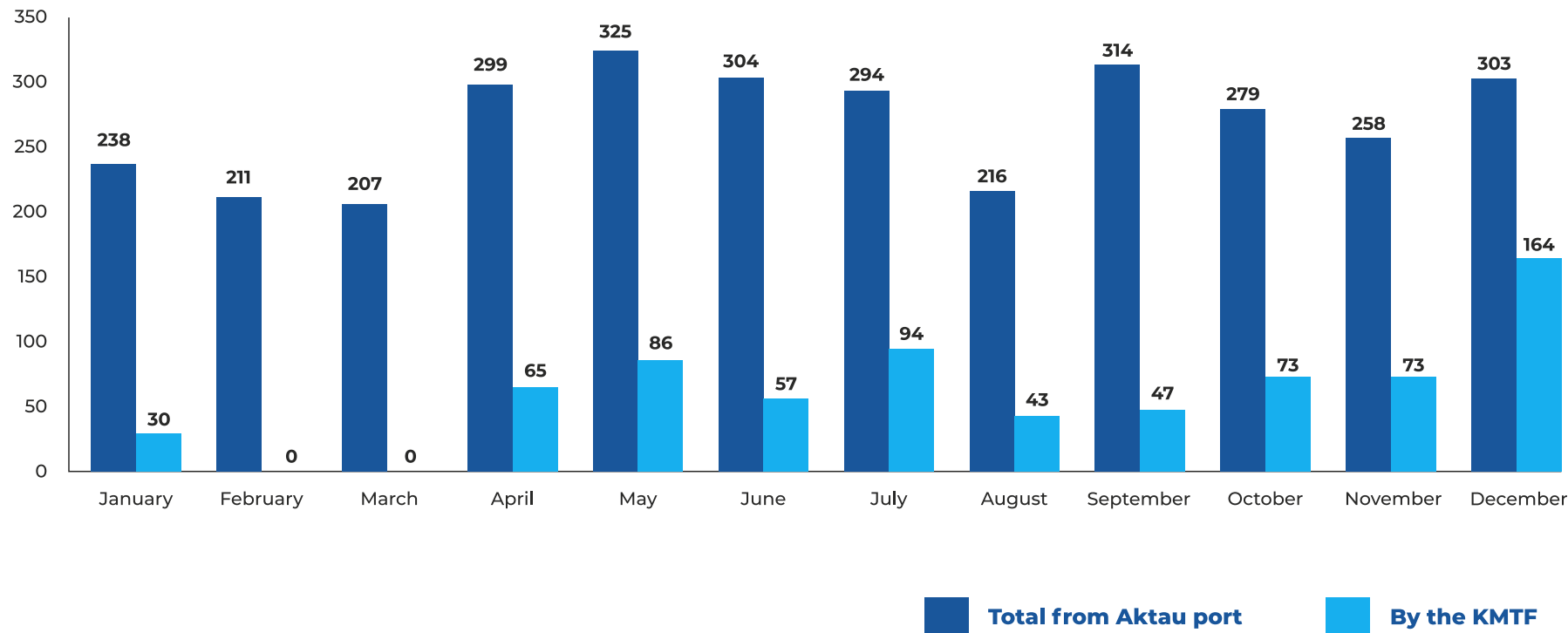

In order to diversify the export routes of Kazakh oil, in November 2022,
KMG and SOCAR signed a General Agreement on the transit of
1.5 million tons of oil per year along the Aktau-Baku-Ceyhan route.

As part of this Agreement, in January 2023, KMTF and SOCAR
Midstream Operations LLC signed an agreement on the
transportation of oil along the Aktau-Baku route, where KMTF was
appointed as the marine operator from the Kazakhstani for the
transportation of oil by sea.

In April 2023, KMTF carried out the first voyage with Tengiz oil
on board towards the port of Baku.

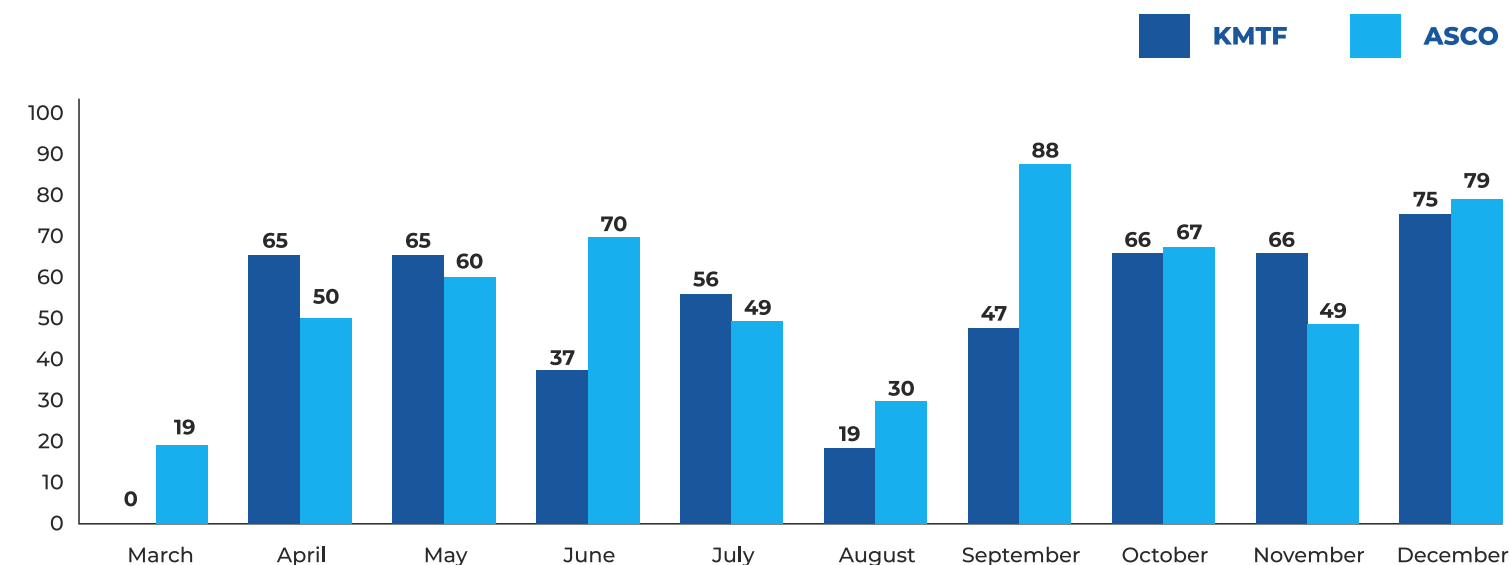

TCO OIL FORWARDING

The integrated approach of KMTF to the provision of freight forwarding services in the port of Aktau allows TCO, without prejudice to the downtime of ships in the port of Aktau and other possible costs, to transport oil in accordance with planned shipment schedules. This was achieved due to the long-term experience of KMTF and cooperation with other operators involved in the technological scheme of rendering services, including, but not limited to:

- JSC "KazTransOil"
- JSC "NC "KTZ"
- JSC "Kaskor-Transservice", surveyors
- JSC "NC "Aktau Commercial Sea Port"
- border guards and customs authorities
- the "State Institution "Maritime Administration of Aktau and Bautino ports", etc.

Transportation of TCO crude oil in 2023 (thousand tons)



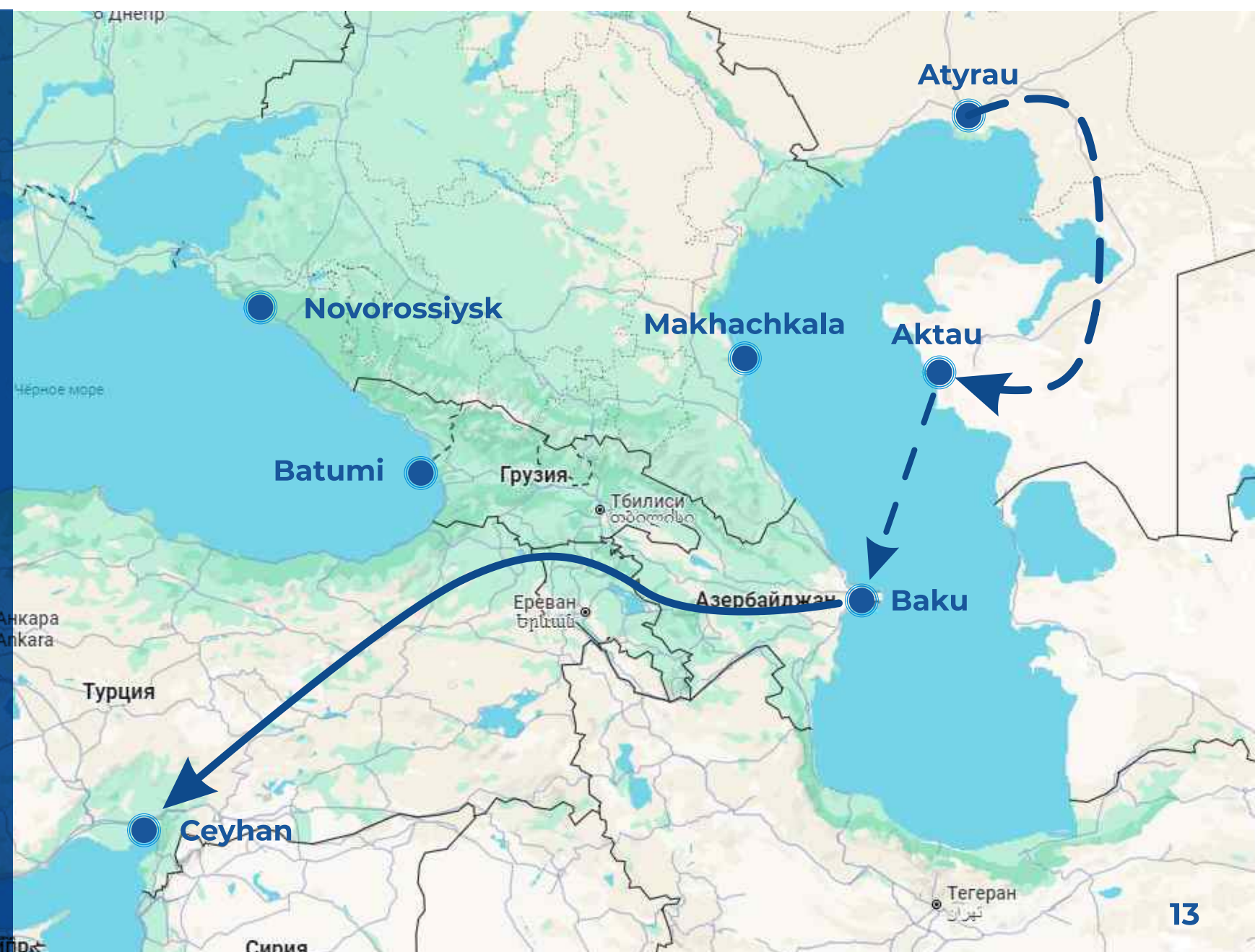
For the purpose of operational processing of its own vessels, KMTF has a 24-hour Dispatch Service, which allows round-the-clock work operations on forwarding and agency of vessels. The trained and trained personnel of the dispatch service have a direct specialized connection for the exchange of information with KMTF vessels.

KMTF operated two of its own tankers on the Aktau – Sangachal line during the transportation of Tengiz oil: "TC Aktau" and "Astana".

According to the Intergovernmental Agreement between the Republic of Kazakhstan and the Republic of Azerbaijan, the share of oil transportation is regulated by a 50/50 volume distribution.

The interests of the KMTF in all ports of the Caspian Sea are represented by nominated maritime agents who ensure the solution of all issues related to the transportation of cargo, in particular Tengiz oil.

Also, in accordance with the current agreement with the port of Aktau, KMTF carries out the installation of tankers at the port's oil berths. This service is provided by TCO in accordance with the current contract for the provision of forwarding services to TCO.

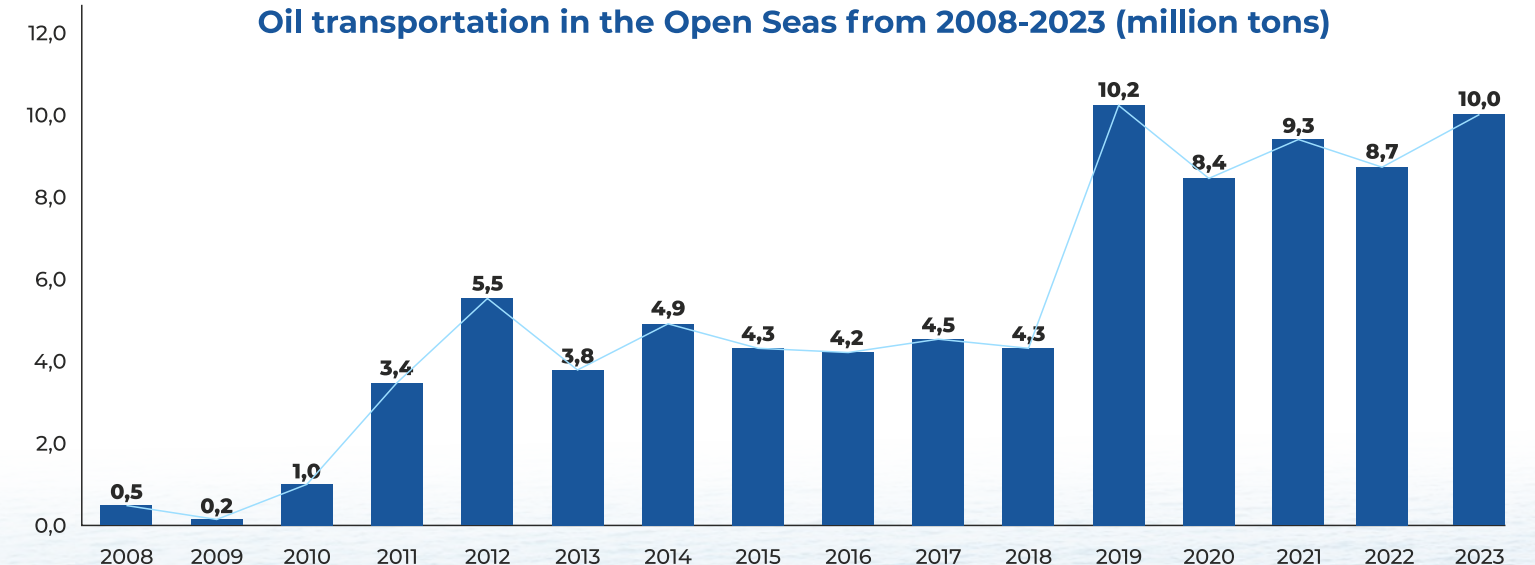

MAINTENANCE OF OIL AND GAS FIELDS ON THE CASPIAN SHELF

As part of the construction of the V-1 exploration well, according to the Contract for the Exploration and Production of Hydrocarbons at the "Zhenis" site located in the Kazakh sector of the Caspian Sea, on August 23, 2022, an agreement was signed between KMTF and "Zhenis Operating" LLP for the provision of services for 4 supply vessels and 2 anchor cutters. The period of service provision is from August 2022 to May 2023.

According to the terms of the agreement, KMTF provided three supply vessels with a service life of 110 (one hundred and ten) calendar days for each vessel and 2 anchor cutting vessels with a period of 10 (ten) days and the provision of services to marine supply vessels to perform the following tasks:

- winding and tightening anchors of a floating drilling rig at the well drilling point V1;
- delivery (and export) of goods to the drilling rig, including dangerous goods, equipment, fuel, water, passengers and their export;
- removal of drilling sludge in containers and other industrial and household waste from the drilling rig;
- ensuring the readiness of the vessel for fire extinguishing, in the event of a fire in the work area (on the SSFDR) during the work on the construction of wells at the Zhenis site;
- Participation in emergency rescue operations and training alarms conducted by the Customer.

Results of the work of the MOSF (Marine Operations Support Fleet)

KMTF owns

3 units

of multi-purpose shallow-seated tugs "Talas", "Irgiz" and "Emba".

From September 16, 2023, 2 units. "Talas" and "Emba" were transferred to a long-term lease under a bareboat charter agreement to OFCO, a company based in Abu Dhabi, UAE. The tugboat Irgiz will be leased in January 2024.

Bareboat charter agreements with OFCO for 3 tugboat units have been signed for 3 years with the possibility of prolongation of the contract period.

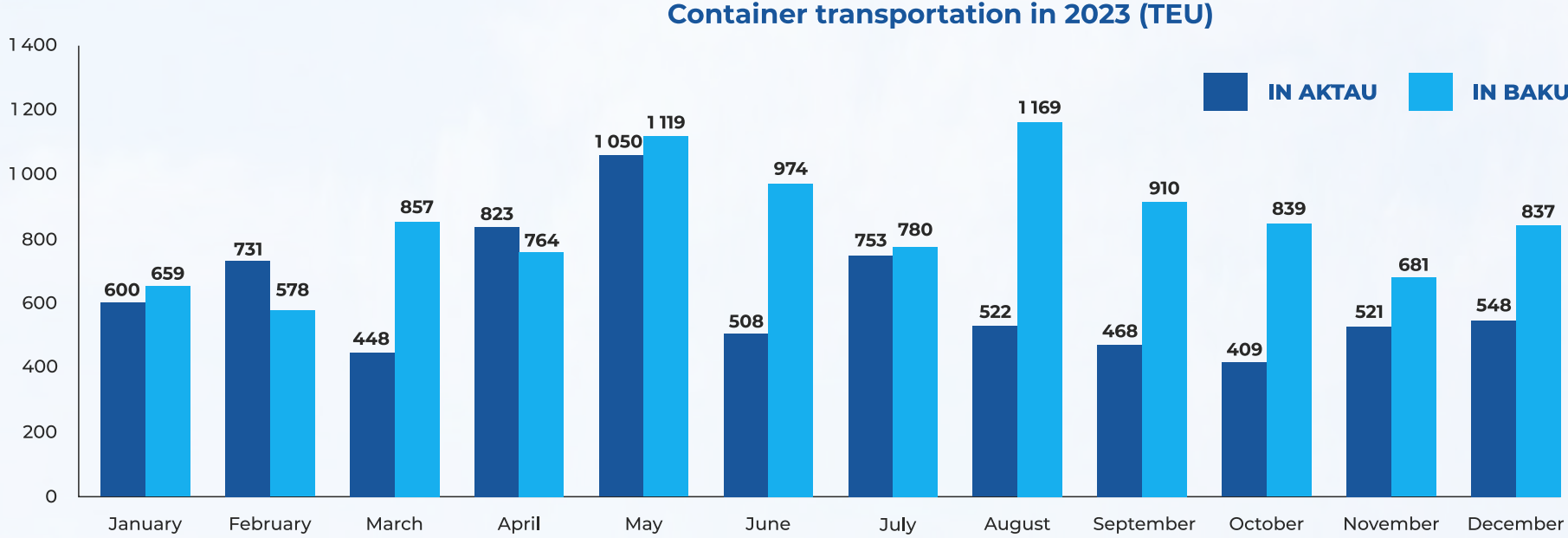

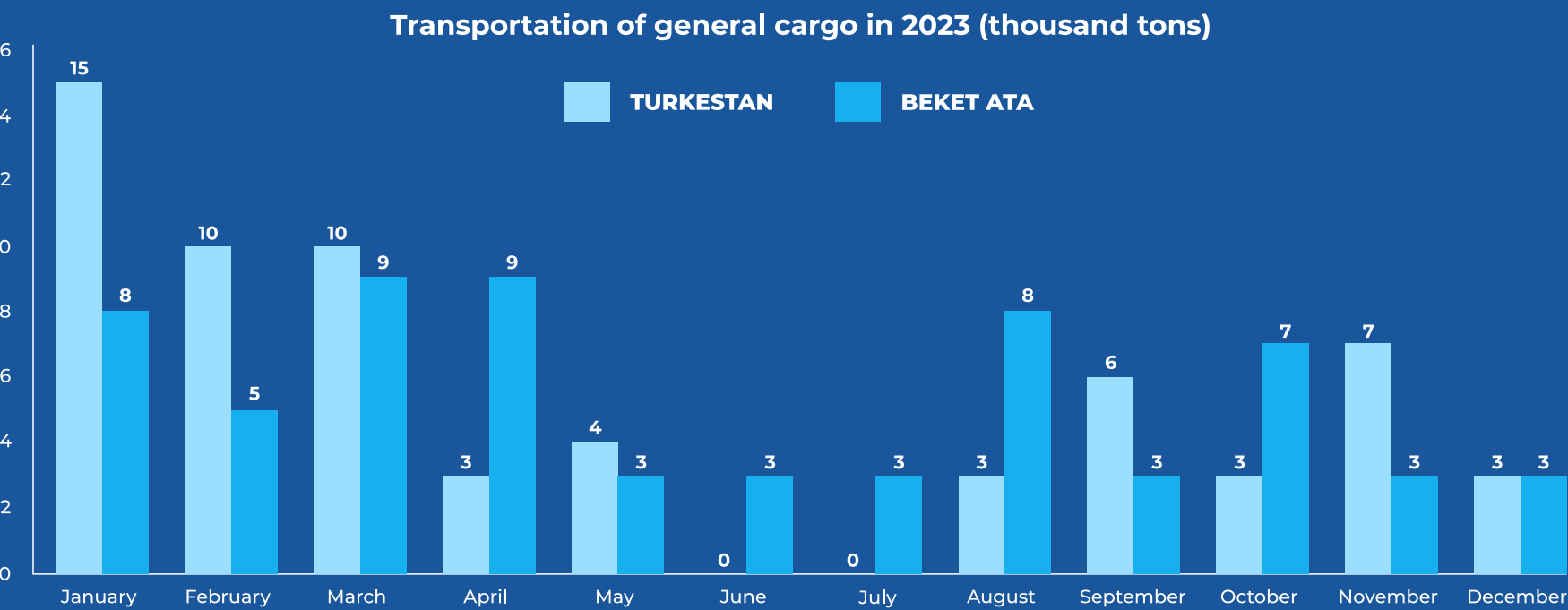

In 2023, the Turkestan and Beket-Ata dry cargo ships were operated on the "Begdash"- "Baku", "Aktau" – "Baku", "Astrakhan" – "Southern Ports of the Caspian Sea and Southern Ports of the Caspian Sea - Aktau routes".

Due to the next inspection of the t/h Turkestan in 2023, from June to July, the cargo ship was withdrawn from commercial operation of the fleet, and therefore, general cargo transportation was not carried out.

OCCUPATIONAL SAFETY AND HEALTH

Occupational health and safety in the office

On January 26, 2023

the KMTF Board approved the Code of Leadership and Commitment of Employees to Comply with Labor Protection and Environmental Requirements (Code).

Principles of the Code

All Employees, in order to form and maintain a structure of responsibility, authority and roles in the field of OT and OS at all levels of the KMTF, must follow the following principles:

- **"Any job can be done safely"**

any activity in the KMTF should be based on knowledge of methods of safe performance of work, timely assessment and identification of Risks/Hazardous and Harmful production factors in the field of LP and SE and the adoption of control measures necessary to prevent them and maintain them at an acceptable level;

- **"Responsibility in the field of LP and SE is personal and proportional to the level of the position held"**

the higher the level of the position and the broader the scope of authority of the Employee, the higher his responsibility and expected contribution to ensuring the requirements of LP and SE;

- **"I do not pass by danger"**

when observing unsafe actions and unsafe conditions, each Employee is obliged to prevent possible Accidents in this regard, to minimize Risks/Dangerous and Harmful production factors;

- **"We do not identify guilty Employees"**

we identify the root (systemic) causes of inconsistencies, ways to solve them during the investigation of Incidents and effective actions to eliminate them.

Vital rules of the KMTF

On May 31, 2023,

the Decision of the KMTF Board approved the Corporate Standard in the field of occupational safety and health "Vital rules" for KMTF employees (CS VR), based on this decision, the Code of KMTF Employees in the field of occupational safety and health "Golden Rules" was declared invalid.

The CS VR provide key requirements for the safe performance of work, developed on the basis of international best practices in the field of occupational safety and health of leading oil and gas companies, provide simple, clear and consistent information about risks in the workplace and the appropriate use of protective equipment/barriers to protect workers.

OCCUPATIONAL SAFETY AND HEALTH

Fire safety inspection

In accordance with the Order of the Minister of Emergency Situations of the Republic of Kazakhstan dated February 21, 2022 No. 55 On Approval of Fire Safety Rules, the Department of Emergency Situations of the Mangystau Region (hereinafter – the Ministry of Emergency Situations of the Ministry of Defense) conducts an annual fire safety inspection in the KMTF Administrative Building.

Occupational health and safety on ships

During the period of 2023, KMTF employees were provided with free medical services according to the contract. In 2023, the contract was concluded with Софи Медгрупп/Sofie Medgroup Multidisciplinary Clinic LLP (hereinafter referred to as the Contractor), within the framework of the contract, the Contractor organized and conducted a mandatory annual medical examination for KMTF employees. For this purpose, a contingent of professions and a list of persons subject to medical examination were compiled and agreed upon by the State Institution "Department of Sanitary and Epidemiological Control of the Mangystau region of the Ministry of Health of the Republic of Kazakhstan".

The main purpose of the ship's occupational safety and fire safety inspection is to determine the mandatory requirements for occupational safety and fire safety, minimizing costs, both financial and temporary, for the implementation of measures to ensure occupational safety and fire safety.

In 2023, internal occupational safety and fire safety inspections were conducted on 11 vessels according to identified checklists according to 01-ISM Company Safety Management Guidelines.

Inspections 2022-2023

In accordance with the approved audit schedule, inspections were carried out on the vessels: "Talas", "Emba", "Irgiz", "TC Aktau", "Almaty", "Astana", "Barys", "Berkut", "Sunkar", "Beket-Ata" and "Turkestan".

Radiation safety and radiation control (RS and RC)

In order to transport dangerous goods of Class 7 by sea in accordance with the legislation of the Republic of Kazakhstan, KMTF received a license for the type of activity "Transportation, including transit, of nuclear materials, radioactive substances, radioisotope sources of ionizing radiation, radioactive waste within the territory of the Republic of Kazakhstan". The licensor is the State Institution "Committee for Atomic and Energy Supervision and Control". Ministry of Energy of the Republic of Kazakhstan.

In order to operate the transportation of goods from ionizing sources, KMTF, due to production necessity, plans to purchase/lease dosimeters and train office staff and ship crews according to the courses of the Republic of Belarus and the Republic of Kazakhstan.

The license was obtained, further, for transportation by sea vessels outside the Republic of Kazakhstan within the framework of the international IMDG code, it was necessary to present the vessels to the classification society in order to obtain a certificate for the transportation of dangerous goods of class 7.

Based on the requirements and rules of the classification society "Appendices to the Manual on Technical Supervision of Ships in Operation" 2.3.2 Requirements for ships carrying dangerous goods of Class 7, vessels were prepared and equipped for the carriage of dangerous goods of Class 7.

- A "Justification for the possibility of transporting a vessel to dangerous goods of Class 7 has been developed, presented and approved.
- A certificate has been received from the classification society for the transportation of dangerous goods 7, based on the attached license and presentation of the vessel in port.

The "Barys", "Berkut" and "Sunkar" naval vessels are provided with an emergency radiation safety kit.

The certification of workplaces was carried out on the "Barys", "Berkut" and "Sunkar" naval vessels.

ENVIRONMENTAL PROTECTION

Hazardous waste

The KMTF waste management system includes organizational measures for tracking waste generation, control over collection, storage, disposal and their neutralization. According to the concluded contracts, all types of production and consumption waste are transferred to specialized contractors for further processing as they accumulate.

Measures designed to reduce the negative impact of production and consumption waste on the environment and to clearly systematize the processes of formation, disposal and neutralization of all types of waste are implemented in accordance with current environmental legislation and international conventions ratified by the Republic of Kazakhstan in the field of merchant shipping.

In 2023, the contractor ("West Dala" LLP, Вест Дала) organized the removal and disposal of hazardous waste.

Waste water

During the reporting period, all wastewater from ships was delivered to onshore receiving facilities to specialized contractors ("West Dala" LLP, Вест Дала) for further purification (disposal).

Analytical control of conditionally clean waters

Work has been carried out to control the quality of discharged conditionally clean waters from ship-wide systems and power plant systems of ships in the Caspian Sea. During the reporting period, in accordance with the concluded agreements No. 812051/2023/1 dated February 07, 2023, with "Center Expert Group" LLP, 4 stages of analytical control of conditionally pure waters discharged into the Caspian Sea from ships were performed. No exceedances of the maximum permissible concentrations were recorded.

Emissions from stationary sources

Emissions of pollutants into the atmosphere from stationary sources of pollution during the reporting period were within the established standards, no excess was recorded for any ingredient.

Environmental inspection on ships (EI)

The main purpose of the inspection is to determine the environmental condition of the vessel, the degree and nature of its impact on the environment, its compliance with the requirements of legislation, norms and rules in the field of environmental protection, international conventions.

In 2023, internal environmental inspections of 10 vessels were carried out according to identified checklists, the identified comments were eliminated qualitatively and on time in accordance with clause 12.5.01-ISM The company's Safety Management Manual.

In accordance with the Law of the Republic of Kazakhstan "On Compulsory Environmental Insurance" dated December 13, 2005 No.93-III of the KMTF Air Defense System, a compulsory environmental insurance contract was concluded, the object of which is the property interest of a person engaged in environmentally hazardous types of economic and other activities related to his obligation, established by the civil legislation of the Republic of Kazakhstan, to compensate for damage caused to life, health, property of third parties and (or) the environment as a result of its accidental pollution.

During the period of 2023, no insurance cases were recorded under the Compulsory Environmental Insurance Contract.

In order to increase attention to environmental protection activities, reduce environmental impact, as well as take measures to meet new environmental requirements and global trends, the KMTF implemented such activities as organizing and participating in the Earth Hour campaign, measures to improve the territory of the administrative building with the planting of trees and shrubs, holding a clean-up day timed to for the International Day of the Caspian Sea.

In accordance with paragraph 5 of the Rules for the Formation and Maintenance of the State Energy Register, "NMSK Kazmortransflot" LLP, as a subject of the State Energy Register, annually submits information on the consumption of energy resources of the SER subject for the reporting period to the National Institute for Development in the Field of Energy Conservation and Energy Efficiency Improvement by April 1.

SAFETY OF SHIP OPERATION

One of the main principles of KMTF's work is to ensure safe, efficient and economical operation of ships in compliance with the requirements of international standards by implementing them into the company's existing management systems.

In order to strengthen the KMTF's leading position in the marine industry, ensure competitive advantage and sustainable development, one of the KMTF's annual main tasks is to improve the effectiveness of the Safety Management System (hereinafter referred to as the SMS). The SMS has been implemented in the Company since 2006 and approved by the Classification Society, in accordance with the requirements of the International Code for the Management of Safe Operation of Ships and Pollution Prevention (hereinafter - ISP Code).

In this direction, during 2023, the KMTF carried out appropriate activities:

Tanker fleet

- Preparation and presentation of oil tankers for passage to the SIRE vetting inspection was carried out, within the framework of the TCO cargo transportation agreement. Dates of SIRE inspections: "Aktau TC - January 26, July 17 and December 28, 2023, Astana" - March 21 and October 23, 2023. The results of the inspections were found satisfactory by the customer in the person of TCO;
- Work has been carried out on the preparation of the "Taraz" and "Liwa" vessels for inspection by the Bureau Veritas Maritime Classification Society and the commissioning of vessels into commercial operation. In the process of preparation, radio licenses, certificates of flag, ownership and minimum composition were issued for the vessels, an agreement was signed with the emergency response service, ship identification and long-range tracking systems (LRTS).

Dry cargo fleet

- Preparation and presentation of oil tankers for passage to the SIRE vetting inspection was carried out, within the framework of the TCO cargo transportation agreement. Dates of SIRE inspections: "Aktau TC - January 26, July 17 and December 28, 2023, Astana" - March 21 and October 23, 2023. The results of the inspections were found satisfactory by the customer in the person of TCO;
- Work has been carried out on the preparation of the "Taraz" and "Liwa" vessels for inspection by the Bureau Veritas Maritime Classification Society and the commissioning of vessels into commercial operation. In the process of preparation, Radio licenses, Certificates of flag, ownership and minimum composition were issued for the vessels, an agreement was signed with the emergency response service, ship identification and long-range tracking systems (LRTS).

Offshore fleet

- Development of an Action Plan to ensure the safe parking of the tugboat Irgiz for the period of 2023, coordination with the MAP of the Republic of Kazakhstan and the Classification Society "Russian Maritime Register of Shipping" (hereinafter – RMRS);
- Within the framework of the project on the haul of tugs "Talas", "Emba" and "Irgiz", an analysis and staffing of vessels was carried out in accordance with their navigation area, including special rules for the independent passage of the GDP of the RF, as well as the passage of ships through waters with an increased risk of piracy;
- As part of the sale of the KMG 105, 106, 107 and 108 barge sites, an inventory was carried out, the transfer of goods and materials to a warehouse in the port of Bautino, the preparation of documents, acceptance certificates and further transfer of barges to the buyer; Control of the loading of ionizing radiation Sources in the Aktau seaport together with a specialist in radioactive materials for transportation under the "Zhenis" project, consideration and approval of the necessary documents for dangerous goods.

Security management System

- In the period of 2023, the following SMS procedures were updated for the ships "TC Aktau", "Astana" and "Almaty": SOLAS procedure, Procedure for pumping petroleum products from ship to ship, Procedure for lifting a person out of the water, Updating the procedure of SMS 02-ISM "Ship Safety Management Manual" to comply with TMSA standards regarding the safety of navigation;
- As part of the commissioning of the "Taraz" and "Liwa" vessels into commercial operation, in order to comply with the ISM Code and SOLAS, such procedures were developed as: A practical guide to SOLAS, a procedure for pumping petroleum products from ship to ship, an emergency towing booklet, a procedure for lifting a person out of the water, a Mooring system Management Plan, a system maintenance services;
- Development and approval of the SOLAS training manual procedure for "Beket-Ata" and "Turkestan" bulk carriers;
- Making corrections to the Practical SOLAS Manual for the Barys vessel;
- Ship-to-shore exercises were conducted with the vessels "Aktau TC", "Astana", "Almaty", "Beket-Ata", "Berkut", "Sunkar" and "Barys". A total of 7 ship-to-shore exercises were conducted on the following topics: Fire fighting, Abandonment, Ship collision and stranding, Emergency ship management, "Man overboard" and "medical evacuation".

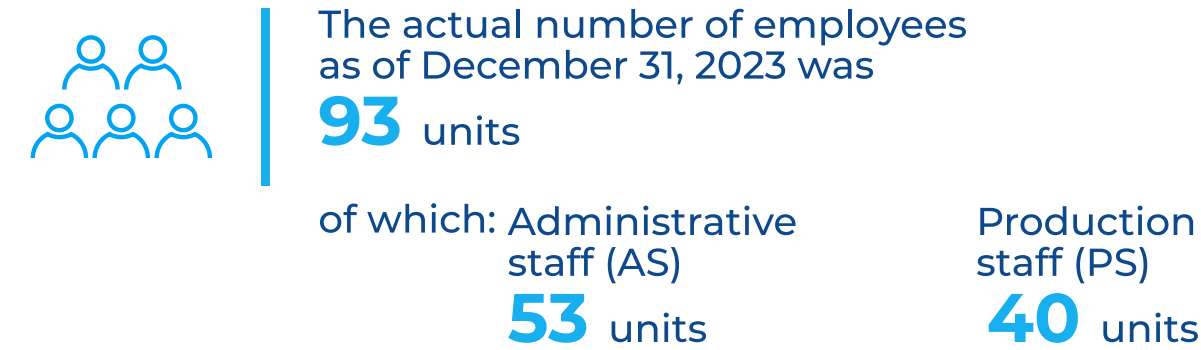
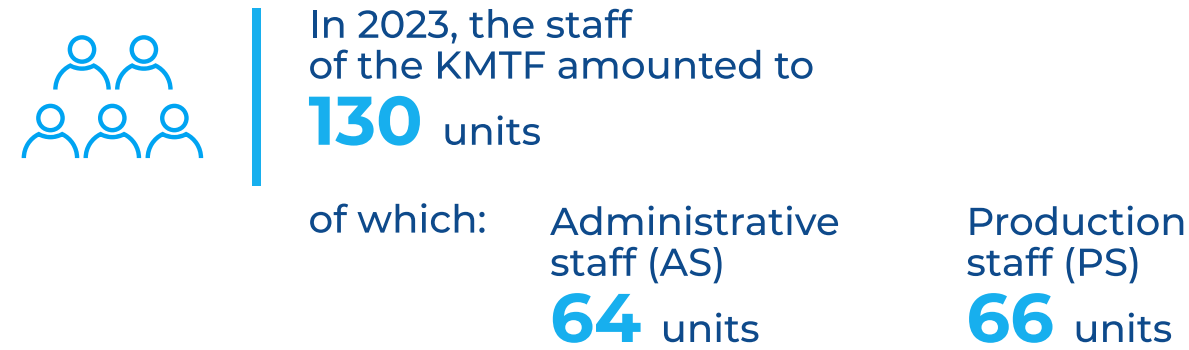
Interaction with the Flag Administration, classification Society

- Assistance was provided to the crew of ships in passing by port control inspectors when entering the ports of the Russian Federation, Azerbaijan and Iran. In total, 25 PSC (Port State Control) inspections were carried out on the company's ships during the period 2023. According to the results of the inspections, no shortcomings were identified that could serve as a reason for the detention of ships;
- Obtaining a certificate from the RMRS Register for the transportation of radioactive cargo for the general cargo "Barys";
- Permission has been received from the Flag Administration of the Republic of Kazakhstan for the temporary transfer of tugs "Irgiz", "Talas" and "Emba" under the flag of the Commonwealth of

- The largest proportion of KMTF employees is between the ages of 23 and 50, which is 88.17% of the total KMTF staff, of which 26.8% are women;

The recruitment of KMTF personnel was carried out in accordance with the KMTF STP.026 "Rules of competitive selection for vacant positions and adaptation of personnel of "NMSC "Kazmortransflot" LLP, so in 2023, 10 people were hired at KMTF, of them: AS - 6 people, PS - 4 people.

During the reporting period, employment relations with 9 employees were terminated, of which: AS - 7 people, PS - 2 people.

13 people have been awarded various awards by KMG and JSC "NWF Samruk-Kazyna" (hereinafter referred to as the Fund), of which: A commemorative badge – 5 people, Certificates of Honor - 8 people.

The Ministry of Industry and Infrastructure Development (Ministry of Transport) of the Republic of Kazakhstan has 8 people, including: A medal - 1 person, a badge - 5 people, a Certificate of Honor - 2 people.

Staff turnover in 2023 was 10.4%, of which: AS – 8.1%, PS - 2% against staff turnover in 2022, which amounted to 16.8%, of which: AS - 9.3%, PS - 6.9%.

Staff training and development

The training, retraining and advanced training of KMTF personnel was carried out in accordance with the Rules of Training and Development of KMTF Employees.

Social policy and stability

In order to improve the socio-psychological climate of the KMTF, according to the Regulations of the KMTF unified internal communications system, reporting meetings of the CEO (Chairman of the Board) of the KMTF with the KMTF workforce were held every six months.

Also, for a closer discussion of work processes and timely elimination of emerging problems, the heads of KMTF functional units held quarterly meetings with employees of supervised departments.

In order to motivate and financially stimulate, by the decision of the KMTF Supervisory Board dated March 07, 2023 (Protocol No. 01-23/SB), starting January 01, 2023, a salary increase of 9.5% was made to KMTF administrative, managerial and production personnel.

Along with this, according to STP KMTF.093 "Rules of remuneration for administrative, managerial and production personnel", holiday bonuses were paid to all KMTF personnel on time, and a bonus was also paid for the 25th anniversary of the KMTF. Quarterly bonuses were paid in accordance with STP KMTF.067 "Rules for evaluating the activities of administrative and production personnel".

In its activities, KMTF actively participated in socially significant events in the region, KMG and KMTF in general, including:

- senior specialist of the Administrative and Economic Department Esniazova A.S. took part in concerts in honor of the opening and closing of the "Uzdik Maman-2023" competition (Best Employee - 2023) among employees of the KMG group of companies;
- in the annual Spartakiad among the KMG Group of companies, in such sports as: volleyball (women's and men's teams), swimming, table tennis, chess, tug of war (arkan Tartu);
- congratulations to WWII veterans in Aktau in honor of the Victory Day celebration on May 9;
- holding a clean-up day in the coastal zone of Aktau;
- participation in the competition of the "Club of the Cheerful and Resourceful" among such companies as JSC "NC "Aktau Commercial Sea Port", "Port Kuryk" LLP, "Aktau Marine Northern Terminal" LLP and the representative office of JSC "KTZ Express" in Aktau in honor of the 60th anniversary of JSC "NC "Aktau Commercial Sea Port";
- organization of volleyball competitions in honor of the 25th anniversary of the KMTF among such companies as JSC "NC Aktau Commercial Sea Port", "Port Kuryk" LLP, "Aktau Marine Northern Terminal" LLP, "Teniz-Service" LLP;

In order to create favorable conditions for the employee, as well as to establish social and labor relations, various types of financial assistance were provided at KMTF, annual medical insurance of employees and their family members was carried out, the children of employees were provided with New Year's gifts.

In August 2023, 38 children of employees, accompanied by 2 KMTF employees, were sent to the "Arman Dala" children's health camp in the Almaty region.



CORPORATE SECURITY

The KMTF corporate security system is designed to support the corporate culture and values of the company, to ensure the protection of employees, financial and technical means, property, technologies, processes of production, management and commercial activities from various threats.

KMTF undertakes obligations to conduct business involving the implementation of production activities in full compliance with international requirements, the requirements of the legislation of the Republic of Kazakhstan and Policies in the field of economic, internal, physical and information security (cybersecurity).

Internal security

In terms of corporate security compliance, the KMTF has expanded the internal video surveillance system, upgraded the building access control and management system. Admission to the KMTF building is carried out by means of biometric data (face recognition), admission of cars to the parking lot – by recognition of state registration plates.

Information security

In order to comply with and monitor information security, KMTF continuously monitors compliance with legislative requirements and international standards in the field of information security, checks workstations for malicious software, and updates information about users in Active Directory;

- The issue of connecting to the Internet through a Single Internet Access Gateway (ESDI) planned in 2023 has been worked out;
- The centralized Electronic Document Management System (KMG EDMS) "Directum" has been implemented;
- The ORDA project has been successfully implemented in terms of combining the KMG domain architecture into a single system with connection to a single data transmission network.

KMTF provides:

- **economic security**
through the implementation of preventive measures to combat fraud and corruption, especially in the field of procurement, preventing theft and misuse of funds, abuse and abuse of official authority, negligence, etc.;
- **internal security**
through systemic prevention and prevention of internal threats;
- **physical safety**
in accordance with legal requirements;
- **information security**
by preventing losses and damage from cyber attacks, preventing unauthorized access to information resources, functioning and improving the effectiveness of the information security management system implemented in the Company based on the Cyber Shield project.



RISK MANAGEMENT

Risk management at KMTF is carried out in accordance with the risk management policy, which defines the goals and objectives of the risk management system, the basic principles of its functioning, the structure and methods of the organization. The main purpose of the corporate risk management system is to achieve the company's operational goals through regular analysis and assessment of production and non-production risks, development of risk management action plans, as well as control and maintenance of an acceptable level of risk appetite. The development of the risk management system is based on international standards such as COSO "Risk Management of organizations. Integrated Model", ISO 31000:2018 "Risk Management. Principles and guidelines", and ISO 31010:2011 "Risk Management. Risk assessment methods".

The KMTF conducts regular and one-time events aimed at preventing risks or minimizing the likelihood of their implementation. The priority areas are: maritime safety, monitoring of global freight markets, modernization and renewal of the fleet, planning and implementation of environmental protection measures, monitoring of regulatory changes in maritime transport, and improvement of personnel policy.

COMPLIANCE AND ANTI-CORRUPTION

As part of the implementation of paragraph 3 of Article 16 of the Law of the Republic of Kazakhstan "On Combating Corruption" by the decision of the KMTF Supervisory Board No.03-22/SB dated May 24, 2022, a separate full-time compliance officer unit was introduced into the KMTF structure, whose task is to build an effective compliance system that provides reasonable assurance that significant compliance and corruption risks of the company properly managed.

The Compliance officer is called upon to ensure compliance with the anti-corruption legislation of the Republic of Kazakhstan, the adoption of compliance policies, as well as the formation of an internal corporate culture based on the principles of transparency and reliability in accordance with legislation and best international practices.
The function of the Compliance Officer is regulated by the Regulation on the Compliance Officer.

The main task of a compliance officer is:

1. ensuring the implementation of tools for the prevention and prevention of corruption offenses by the KMTF and its employees;
2. effective implementation of the system of anti-corruption measures in the KMTF;
3. ensuring that the KMTF conducts an internal analysis of corruption risks;
4. ensuring compliance with the legislation of the Republic of Kazakhstan by KMTF structural units, including compliance with external regulatory requirements and international compliance practices, including anti-corruption and fraud, compliance with internal rules, moral and ethical standards;
5. interaction with regulatory authorities and the KMG compliance service;
6. development and control of the Program execution/Compliance plan on an annual basis;
7. development and updating of standards and policies in the field of compliance;
8. conducting, together with interested structural divisions and structural units, a comprehensive audit of counterparties;
9. implementation of the initiative information line;
10. communication and implementation of compliance policies;
11. supervision and control of compliance directions;
12. conducting investigations in case of violations of compliance policies;
13. conducting investigations on reports received by the initiative information line.

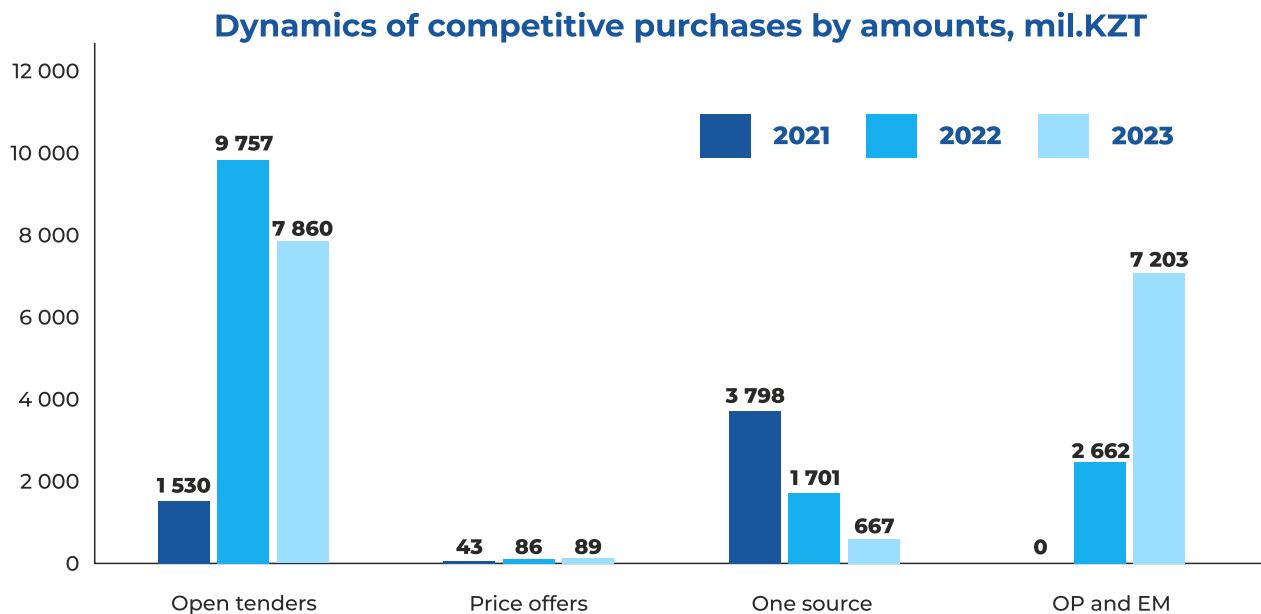

As follows from the analysis, there is a tendency to significantly increase competitive purchases, both in quantity and in amount, and vice versa, a decrease in the number of purchases from a single source, which is a positive result in the activities of KMTF, taking into account the requirements of both the Fund and KMG, since, among other things, motivational indicators are achieved for procurement activities and corporate KPIs are carried out.



In 2023, as well as in 2022, there are no regulations of the Fund on violations of procurement activities.

It should be noted that in 2023, in order to improve the quality of planning and procurement, develop technical specifications, minimize violations of established procedures and strengthen personal responsibility, KMTF internal documents regulating the procurement process in KMTF were updated, the responsibility of Administrators of budget programs was strengthened, coordination of all purchases from one source and using a special procedure with a compliance officer of the KMTF.

The total share of local content in the procurement of labor in 2023 was 85%, including 95% in goods and 75% in works/services.

INTEGRATED MANAGEMENT SYSTEM

Verification, analysis and evaluation carried out by the company

In order to maintain an integrated management system (IMS), a safety management system (SMS) and verify the activities to ensure compliance of the Company and ships with the requirements of ISO, the International Code for the Management of Safe Operation of Ships and Pollution Prevention (ISM), internal audits of IMS and SMS were conducted in KMTF units responsible for IMS and SMS and on KMTF vessels, according to the Audit Schedule for 2023, as well as technical inspections on KMTF vessels according to the OVPQ questionnaire.

Test results (external and internal according to ISO and ISMC)

The integrated management system of KMTF is currently certified by "URS-Kazakhstan" LLP for compliance with the requirements of the following international and national standards:

The KMTF safety management system is certified by the Classification Society Russian Maritime Register of Shipping (RMRS), Bureau Veritas (BV) for compliance with the requirements of the ISM Code.

First-party audits in KMTF units

According to the requirements of ISO 9001 Quality Management System, ISO 14001 Environmental Management System - Requirements and application guidelines, ISO 45001 Occupational Health and Safety Management System – Requirements and recommendations for the use of KMTF should conduct internal audits (inspections) at scheduled intervals in order to establish that the quality management system:

- corresponds to the planned events;
- requirements of the ISO 9001, ISO 14001, ISO 45001 standards;
- ISU requirements developed by the KMTF;
- effectively implemented and kept up to date.

The procedure for conducting an internal audit is presented in the internal regulatory document "Internal Audits".

The internal audit of the ISU was conducted in accordance with the audit schedule approved by the CEO (Chairman of the Management Board) for 2023. The order appointed auditors and heads of audit groups from among KMTF employees with the necessary competencies. The audit of the first party was conducted in the divisions located in the office at Aktau, 14 microdistrict, building No. 70.

During the audit, it was established: the availability and relevance of objective evidence of compliance with the requirements of ISO 9001, ISO 14001, ISO 45001.

According to the results of the audit of the first party in 2023, 1 discrepancy and 7 observations were revealed in the divisions.

Deadlines, corrective actions to eliminate and/or prevent the occurrence of inconsistencies and observations are agreed with the Quality Management Sector.

The audit results were compiled into single summary files and posted on a network resource for the convenience of analyzing and storing information.

Lists of identified inconsistencies and measures to eliminate and/or prevent them, agreed with the heads of the audited departments, as well as the measures actually taken, will be evaluated for effectiveness in future audits.

Audit of the first party on KMTF vessels

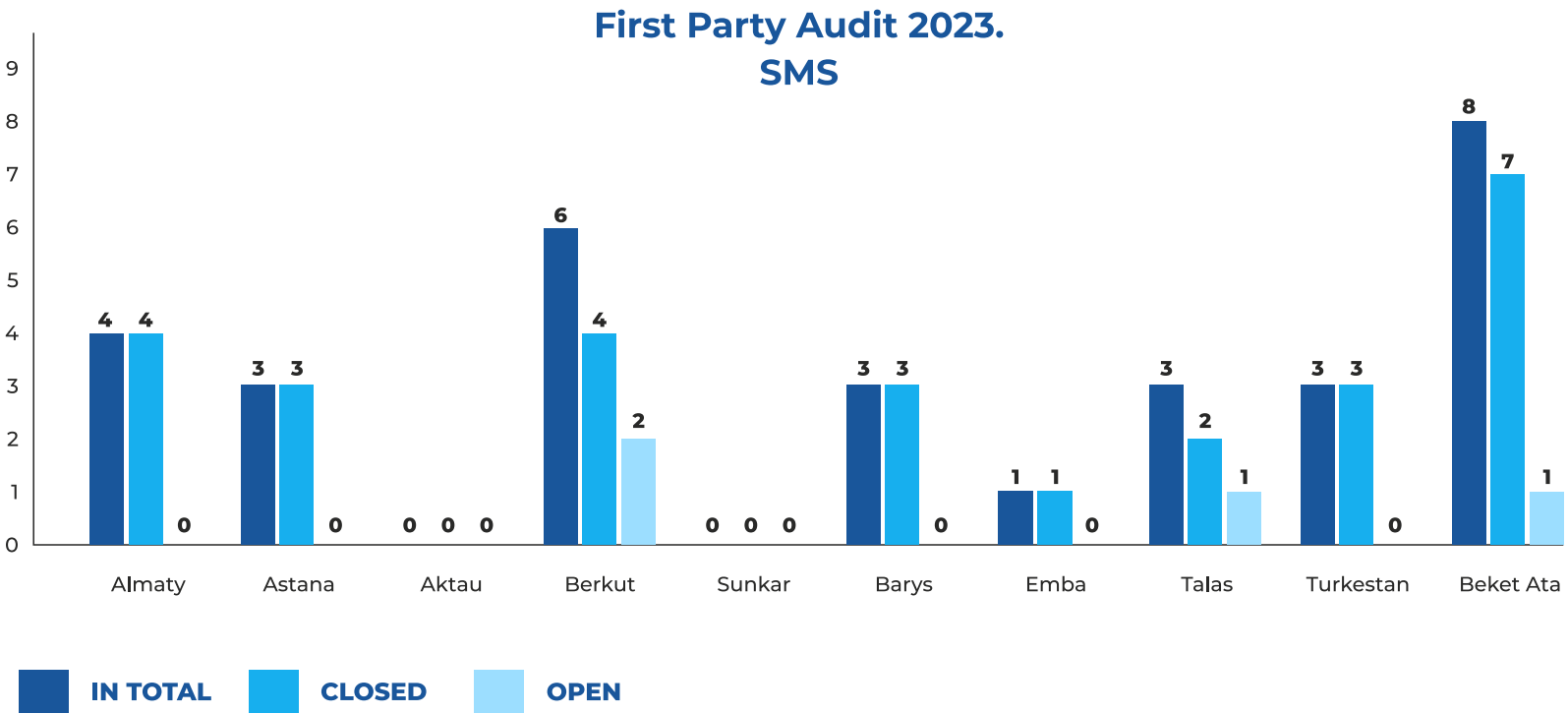
The main objectives of the audit are: Verification of the implementation of the procedures and instructions of the SMS, including the implementation of navigation safety procedures for navigation, the implementation of safety procedures for cargo operations.

The captain of the vessel must eliminate the identified inconsistencies at the prescribed time and report this to the CC Sector.

The management level is considered satisfactory if all the services on the ship perform their duties without comments affecting the safety of the vessel.

The management level is considered unsatisfactory if at least one of the services on the ship does not perform their duties as required and there are comments affecting the safety of the vessel.

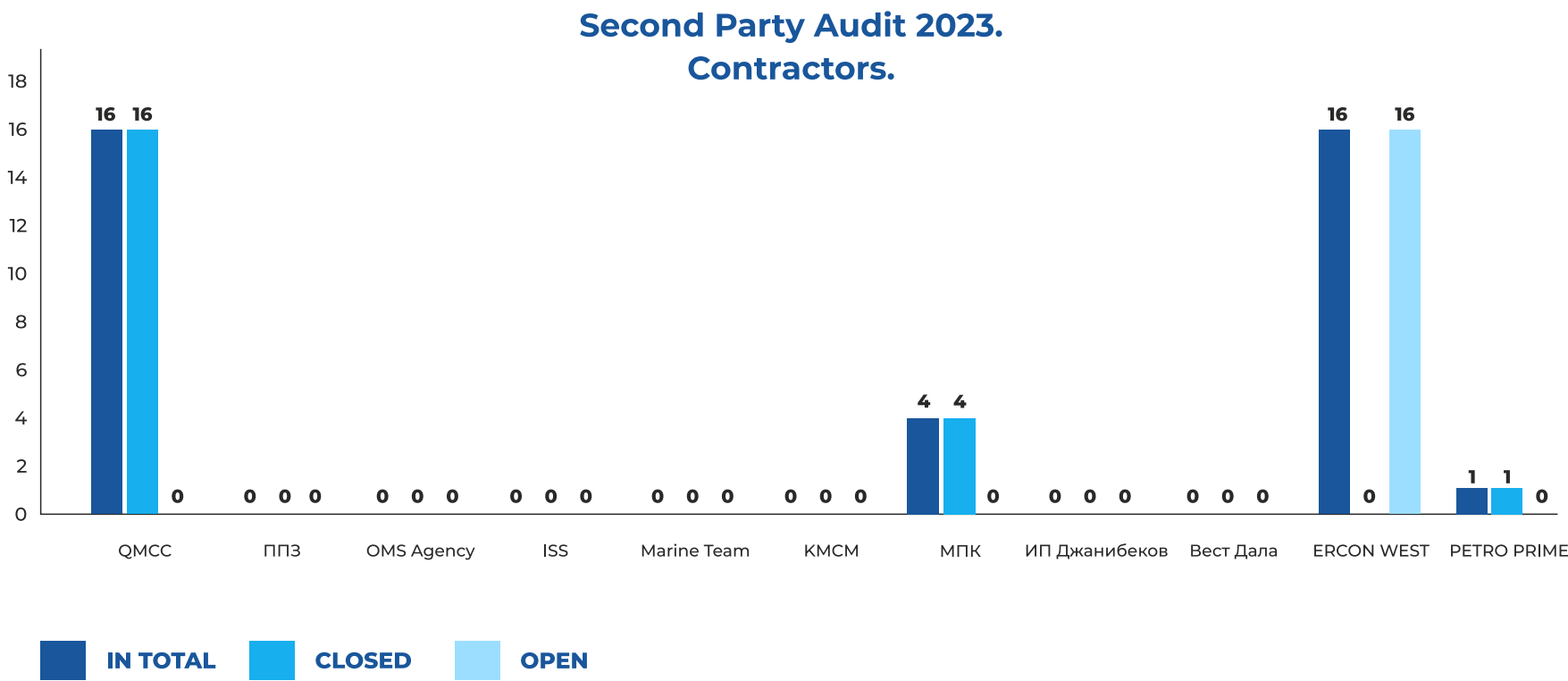
The closure system includes a set deadline for corrective actions, informing the KMTF of the implementation and confirming the KMTF.



Audit of the second party in KMTF contractors

In accordance with the requirements of KMG, the Fund, the Legislation of the Republic of Kazakhstan, international/state standards and recommendations of the IOGP, policies and CM, in the field of occupational safety, industrial safety and environmental protection (OC, IS and EP), the KMTF has a "Corporate standard for interaction with contractors in the field of occupational safety, industrial safety and environmental protection" (Standard). The purpose of the Standard is compliance by Contractors/Subcontractors in the performance/provision/delivery of the Standard.

During the course of the work/the provision of services by the Contractor is organized and periodic inspections (audits) are carried out, according to the Schedule of inspections approved by the CEO (Chairman of the Management Board) for 2023, compliance of their activities with the requirements of OC, IS and EP. The frequency of inspections is at least 1 (one) time per year.



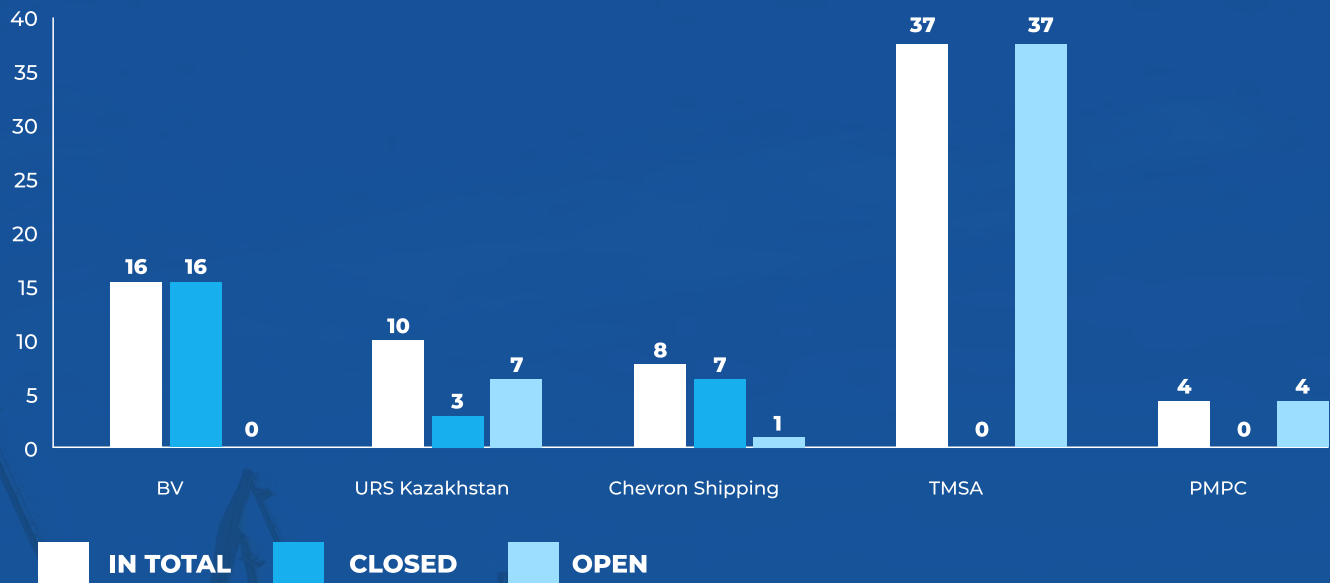
Third Party Audits (KMTF)

In the period 2023, third-party inspections were carried out at the KMTF. In September 2023, KMTF conducted an external inspection audit for compliance with the requirements of international standards ISO 9001, ISO 14001, ISO 45001 and a recertification audit for compliance with the requirements of state standards ST RK ISO 9001, ST RK ISO 14001, ST RK ISO 45001 of the Integrated Management System of KMTF LLP "URS-Kazakhstan".

The audit revealed 10 minor inconsistencies and 6 observations. Of the inconsistencies: 7 to 9001, 2 to 14001, 1 to 45001.

In June 2023, the KMTF Safety Management System was inspected by Bureau Veritas. 16 inconsistencies have been exposed and closed.

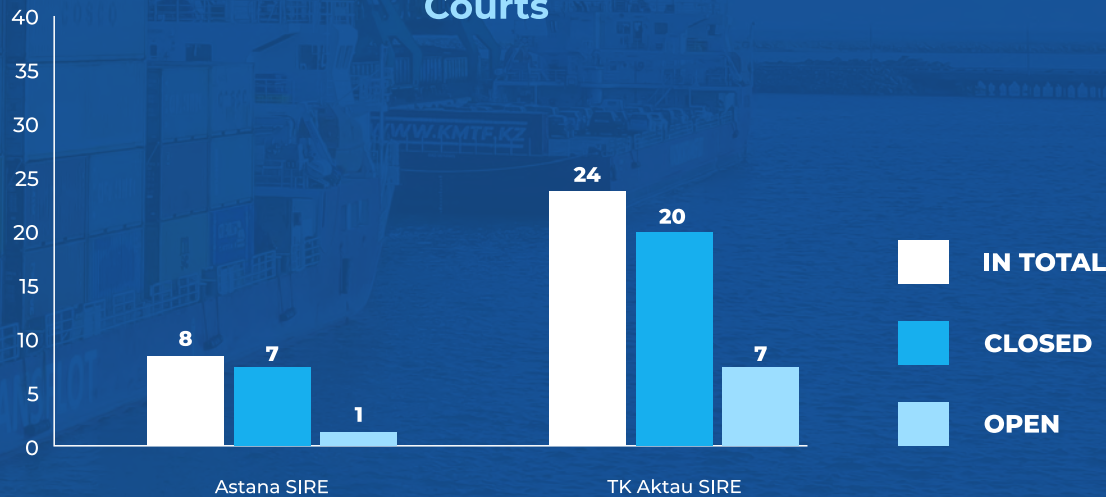


Audits of third parties (Courts)

Opinion
